



All Saints Catholic School

All Saints Catholic School is an integral part of the All Saints Parish family. The parish has a vested interest in the function and vitality of its school. Therefore, active parishioners qualify for a special rate of tuition.

For the sake of tuition, an active parishioner

- has completed the parish registration form and has a registration number;
- regularly attends Sunday Mass;
- participates in some of the various ministries and programs of the community (i.e. Lectors, St. Vincent de Paul, PTG, CYO); and
- makes regular financial offerings using the Sunday envelopes.

Such qualifications must be established at least six months prior to school registration for a family to be eligible for the active parishioner tuition rate. [Please note: If requested, an application for a change of status from non-active to active may be made in December of the first year a student is enrolled in the school.]

For the sake of clarity, non-active membership applies to those who do not fit the above qualifications (although they may be active in their own parish).

Tuition assistance may be available for qualifying families.

STUDENT FEES FOR THE 2009-2010 SCHOOL YEAR

Student fees help pay for the use and consumption of textbooks, health and accident insurance, standardized testing, and diocesan administrative fees. Additional fees pay for graduation expenses, retreats, a Sacramento trip, and science camp.
